It includes a guide, the Reference Framework, that sets out **standards that must be observed to become a compliant municipality**.

As well as **supporting and orienting municipal day camp managers** with practical tools and useful advice, the Reference Framework for Municipal Day Camps guarantees the **safety and quality of activities offered**, while enabling the continuity of existing processes.

ANNUAL FEES


Annual fees are based on the population of the municipality or borough. Add \$75 for each additional site.

Less than 5,000 inhabitants: \$180	30,000 to 49,999 habitants: \$618
5,000 to 9,999 inhabitants: \$360	50,000 or more inhabitants: \$875
10,000 to 29,999 inhabitants: \$463	

The enrolment period runs from October 1 to April 30 each year. Taxes extra.

HOW TO BECOME A MUNICIPAL MEMBER
